SC^{ES} Why SusChem?


- SusChem as the technology platform for sustainable chemistry has a **unique network** throughout the chemical industry and the academic world.







Context

- The EC (DG RTD) is defining guidelines on Safe and Sustainable by Design (SSbD) chemicals, materials, processes and applications
- These guidelines are partly based on the work performed in the nano-materials cluster, focusing on safety
- Some material have already been published, i.e. the "<u>Chemicals Strategy for Sustainability (CSS) Towards a Toxic-Free</u> <u>Environment</u>"
- The EC is planning to publish a more detailed strategy in 2022. The strategy is expected to influence policy, as well as help define R&I priorities that will manifest in Horizon Europe and other calls
- SusChem considers important to liaise with DG RTD and give input to EC's SSbD strategy prior to its publication
- SusChem has already set up Working Groups (WGs) and Value Chains (VCs). A kick-off meeting was held with the WGs in August 2021 to start working on the content of the roadmap
- The starting point of the WGs was a "<u>non-paper</u>" published on the topic in 2019, with some SusChem members as coauthors, and referenced in the SusChem 2019 SIRA.








Organisation of experts

Results from board survey in June 2021


